



What information we collect:

WellShare International collects and uses various personal information from donors that includes: amount donated, address, telephone number, donor comments and e-mail address. Tax laws in the United States and the State of Minnesota require WellShare International to keep contact information and contribution level of donors on file.

How we use that information:

WellShare International will never publish, sell, trade, rent or share names (unless released for publication), e-mail or mail addresses, or telephone numbers of our donors. WellShare International will use contact information (e-mail, telephone number and address) of donors for these purposes only:

- Distribute receipts for donations.
- Thank donors for their donation.
- Inform donors about upcoming fundraising and other activities of WellShare International.
- Internal analysis and record keeping.
- Reporting to relevant U.S. and State agencies (these reports are not for public inspection).
- Contact donors about changes to this policy.

Donors have the option to have their name publicly associated with their donation or not. WellShare International publishes the name of the donor and the general category of their annual giving in the WellShare annual report unless the donor explicitly states their wishes to be anonymous.

Financial information:

All access to donor financial information is strictly limited to professional staff who need to process those data. No such data are given to any person, organization or group who does not need to access those data.

WellShare International only uses online payment processing services with strong security precautions and excellent reputations. WellShare International does not store, nor your credit card information, bank account numbers, or other account data sent to those processing services. These steps provide the highest possible level of security and confidentiality.



WellShare International subscribes to the Donor Bill of Rights.

Philanthropy is based on voluntary action for the common good. It is a tradition of giving and sharing that is primary to the quality of life. To assure that philanthropy merits the respect and trust of the general public, and that donors and prospective donors can have full confidence in the not-for-profit organizations and causes they are asked to support, we declare that all donors have these rights:

1. To be informed of the organization's mission, of the way the organization intends to use donated resources, and of its capacity to use donations effectively for their intended purposes.
2. To be informed of the identity of those serving on the organization's governing board, and to expect the board to exercise prudent judgment in its stewardship responsibilities.
3. To have access to the organization's most recent financial statements.
4. To be assured their gifts will be used for the purposes for which they were given.
5. To receive appropriate acknowledgment and recognition.
6. To be assured that information about their donations is handled with respect and with confidentiality to the extent provided by law.
7. To expect that all relationships with individuals representing organizations of interest to the donor will be professional in nature.
8. To be informed whether those seeking donations are volunteers, employees of the organization or hired solicitors.
9. To have the opportunity for their names to be deleted from mailing lists that an organization may intend to share.
10. To feel free to ask questions when making a donation and to receive prompt, truthful and forthright answers.
